1. That **Tommie Conaway** received the majority of votes for the office of City Council for **District #1**, and is hereby duly elected to office for the term beginning on the first Monday in November, 2025.
2. That **Steve Olen** received the majority of votes for the office of City Council for **District #2**, and is hereby duly elected to office for the term beginning on the first Monday in November, 2025.
3. That **Joel Coleman** received the majority of votes for the office of City Council for **District #3**, and is hereby duly elected to office for the term beginning on the first Monday in November, 2025.
4. That **Oliver Roberts** received the majority of votes for the office of City Council for **District #4**, and is hereby duly elected to office for the term beginning on the first Monday in November, 2025.
5. That **no candidate** received a majority of votes for the office of **District 5 City Council Member**, and that **Stephanie Ganey-Messinger** and **Steve McArthur** received the most and second most votes cast for that office, therefore, a runoff election between said candidates is hereby ordered to be held on Tuesday, September 23, 2025 pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.

6. That **Benjamin Hughes** received the majority of votes for the office of City Council for **District #6**, and is hereby duly elected to office for the term beginning on the first Monday in November, 2025.
