Municipal Election Held August 23, 2016 Canvass Results

WHEREAS, the general municipal election for the City of Daphne was duly and legally held on Tuesday, August 23, 2016, as provided by law; and

WHEREAS, the municipal governing body of the City of Daphne met on the 30th day of August, all members there of being present at 12:00 pm; and has canvassed the returns; and has ascertained and determined the number of votes received by each candidate; and have determined the result of said election as follows:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DAPHNE, ALABAMA, as follows:

1. That **Dane Haygood** received a majority of votes cast for the office of **Mayor**, and is hereby declared duly elected to that office for the term beginning on the first Monday of November 2016.
2. That **Tommie Conaway** received the majority of votes for the office of Councilwoman for **District #1**, and is hereby duly elected to office for the term beginning on the first Monday in November, 2016.
1. That **no candidate** received a majority of votes for the office of Councilman for **District #2**, and that **Larry Chason** and **Pat Rudicell** received the most and second most votes cast for that office, therefore, a runoff election between said candidates is hereby ordered to be held on Tuesday, October 4, 2016 pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.
2. That **D. Joel Coleman** received the majority of votes for the office of Councilman for **District #3**, and is hereby duly elected to office for the term beginning on the first Monday in November, 2016.
3. That **no candidate** received a majority of votes for the office of Councilman for **District #4**, and that **Roland "Randy" Fry** and **Doug "Goody" Goodlin** received the most and second most votes cast for that office, therefore, a runoff election between said candidates is hereby ordered to be held on Tuesday, October 4, 2016 pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.
4. That **Ron Scott** received the majority of votes for the office of Councilman for **District #5**, and is hereby duly elected to office for the term beginning on the first Monday in November, 2016.
4. That **Robin LeJeune** received the majority of votes for the office of Councilman for **District #6**, and is hereby duly elected to office for the term beginning on the first Monday in November, 2016.
